The four primary services offered are Adult Basic Education (ABE), English as a Second Language (ESL), Family Literacy, and Transition Coaching. Further supportive programming for learners includes English conversation, computer literacy and special classes related to job readiness, numeracy, health, financial literacy, civics and other relevant topics. In addition to initial volunteer tutor training, Literacy Advance also provides ongoing enrichment training for volunteer tutors in order to enhance the quality of instruction provided in the classroom.

During 2016, Literacy Advance trained and supported the specialized work of 243 volunteer tutors who contributed 19,256 hours of in-kind service and enabled 1,449 adults to complete 46,932 direct contact hours of literacy instruction. Literacy Advance's volunteer management systems extend support not only to literacy tutors, but also to a large pool of administrative volunteers and a robust internship and work-study program. In addition to providing trained tutors for Literacy Advance programs, training is also provided to volunteer tutors who deliver programming at other community-based organizations.

Literacy Advance volunteers delivered family literacy services to 1,548 adults and children in low-income area schools, churches and community centers and distributed 1,692 children's books for families to start or expand their home library. In total, Literacy Advance provided services to 3,077 direct beneficiaries in 2016. In addition to the main Wilcrest and Bay Area locations, Literacy Advance partnered with 20 organizations to deliver a high-quality literacy program at 20 outreach locations in the community. Through these collaborations, Literacy Advance provides program management and evaluation which allows libraries, colleges, human service nonprofits,
